This letter sets out the terms of our agreement pursuant to which the Committee on Publication Ethics (COPE) will provide membership to COPE for CHINESE GENERAL PRACTICE. Under this agreement, COPE agrees to cap dues at 2020 rates until December 2022 (a period of up to three years).

COPE was established in 1997, and now has over 12,000 members worldwide from all academic fields. Membership is open to editors of academic journals and others interested in publication ethics. The principal activity of COPE is providing advice to editors, publishers and associate members on all aspects of publication ethics and, in particular, how to handle cases of research and publication misconduct. It also provides a Forum for its members to discuss individual cases.

Both COPE and CHINESE GENERAL PRACTICE are independent organisations/individuals. Nothing in this agreement creates or is intended to create a partnership of agency, franchise or employment relationship between COPE and the organisation or individual.

Any information designated by either organisation/individual as confidential shall be treated as confidential by the other organisation/individual and not disclosed to any third party without the express permission of the organisation/individual concerned. Without limiting the generality of the foregoing, internal deliberations of COPE are confidential, and may not be disclosed by CHINESE GENERAL PRACTICE without the prior written consent of COPE. COPE has no obligation to share its internal deliberations with CHINESE GENERAL PRACTICE. CHINESE GENERAL PRACTICE is free to follow COPE's conclusions and recommendations, and any such decisions are the sole responsibility of CHINESE GENERAL PRACTICE. COPE makes conclusions and recommendations on the basis of what COPE believes to be best editorial practices, but fully disclaims any liability resulting therefrom.
